TERMS AND CONDITIONS

- Park Shore Country Day Camp will open on Monday, June 26, 2023. We will be closed on Tuesday, July 4, 2023.
- An enrollment deposit of \$600 is required for each child, which is refundable for any reason up to Friday, March 3, 2023. There will be a 3% administrative fee for credit card charges and a 1% fee for E-checks. You can also pay with check or cash to avoid any fees.
- You must log into your Camp In Touch account online to make a payment via Credit Card or E-check.
- The balance of all tuitions is due no later than Friday, April 14, 2023.
- It is understood that no part of the tuition fee or deposit, except that part covered under our normal sickness refund plan (Non-Covid and Non-communicable diseases), will be refunded after Friday, March 3, 2023. If a camper is absent due to illness or accident, as certified by a physician's letter, for 5 consecutive camp days during the camp session, a pro-rata refund will be made for every day thereafter following our current refund policy. The refund will be made after the camp season is over.
- If a camper has to stay home due to a positive COVID test not related to Park Shore, then our normal illness or accident refund policy will be used.
- In the event camp is unable to open or is forced to begin late or close early due to circumstances beyond Park Shore's control, (heavy rain, high wind, hurricane , etc.) there will be no refunds made.
- If we have to follow New York State COVID-19 mandates which could decrease the capacity on our buses, there will be a prorated \$90 a week charge for Pick-Up and Take-Home transportation. Parents have the option to transport their child and will get a prorated \$40 a week credit.
- It is understood that camp days may not be substituted due to illness or any other absence.
- I hereby give my consent to have my child taken to and from various field trips by means of transportation used by Park Shore Country Day Camp. This policy could change if the New York State COVID-19 Mandate changes.
- In the event that I cannot be reached by phone in an emergency, I hereby give my permission to my family physician, any local physician or hospital and to Park Shore Country Day Camp to administer emergency treatment to my child.
- I hereby grant permission to use any photograph, film or other image of my child for promotional purposes, including but not limited to brochures, DVDs, our website and Facebook page and other on-line postings.
- Binding Arbitration – I agree that any dispute concerning, relating, arising out of or referring to the subject matter of this contract shall be resolved exclusively by binding arbitration in Suffolk County, New York, according to the then existing commercial rules of the American Arbitration Association and the substantive laws of the state of New York.

Park Shore Country Day Camp is licensed by the N.Y.S. Dept. of Health and is inspected twice yearly.
Copies of the inspection are filed in the Health Dept. office in Riverhead.
