TERMS AND CONDITIONS

- Park Shore Country Day Camp will start on Monday, June 30, 2025. We will be closed on Friday, July 4, 2025.
- An enrollment deposit of \$600 is required for each child, which is refundable for any reason up to Saturday, March 1, 2025. There will be a 3% administrative fee for credit card charges and a 1% fee for E-checks. You can also pay with a check or cash to avoid any fees.
- You must log into your Camp In Touch account online to make a payment via Credit Card or E-check @ parkshoredaycamp.com.
- The balance of all tuition is due no later than Thursday, April 17, 2025.
- It is understood that no part of the tuition fee or deposit, except that part covered under our normal sickness refund plan will be refunded after Friday, March 7, 2025. If a camper is absent due to illness or accident, as certified by a physician's letter, for 5 consecutive camp days during the camp session, a pro-rata refund or credit will be made for every day thereafter following our current refund policy. The refund will be made after the camp season is over.
- It is understood that the Explorer and Superteen Travel programs are 5 days per week. No changes can be made 2 weeks prior to the start of the Travel camper's session.
- In the event camp is unable to open or is forced to begin late or close early due to circumstances beyond Park Shore's control, (heavy rain, high wind, hurricane, etc.) there will be no refunds made.
- It is understood that camp days may not be substituted due to illness or any other absence.
- I hereby give my consent to have my child taken to and from various field trips by means of transportation used by Park Shore Country Day Camp.
- In the event that I or my contacts cannot be reached in an emergency, I hereby give my permission to Park Shore, the local ambulance/Fire department, my family physician or the nearest hospital to administer emergency treatment and care to my child. I further give my permission for all pertinent health information to be duplicated and released to the appropriate personnel for emergency care.
- I hereby grant permission to use any photograph, film or other image of my child, for promotional purposes, including but not limited to brochures, DVDs, our website and Facebook page and other on-line postings.
- Binding Arbitration – I agree that any dispute concerning, relating, arising out of or referring, to the subject matter of this contract shall be resolved exclusively by binding arbitration in Suffolk County, New York, according to the then existing commercial rules of the American Arbitration Association and the substantive laws of the state of New York.

Park Shore Country Day Camp is licensed by the N.Y.S. Dept. of Health and is inspected twice yearly. Copies of the inspection are filed in the Health Dept. office in Riverhead.
