- Tuition includes snack, lunch, and camp pictures.
- Toddlers are to be transported by their parent or guardian. Transportation may be available upon request.
- A \$100 deposit is payable at the time of enrollment and will be credited towards the balance. The balance of the full payment is due on or before June 1, 2019 and represents the total cost of the Summer Toddler Program. You can pay with check, credit card, or cash. If you decide to use a credit card, we must have a credit card authorization form on file.
- In the event that I cannot be reached by phone in an emergency, I hereby give my permission to my family physician, any local physician or hospital and to Park Shore Country Day Camp to administer emergency treatment to my child.
- It is understood that all photography and video photography taken at camp may be used for promotional purposes, as well as for projects.
- Due to a limited group size, enrollment is on a first come basis.
- Camp will be closed on Thursday, July 4, 2019 and Friday, July 5, 2019. We will re-open on Monday, July 8th.
- Binding Arbitration – I agree that any dispute concerning, relating, arising out of or referring to the subject matter of this contract shall be resolved exclusively by binding arbitration in Suffolk County, New York, according to the then existing commercial rules of the American Arbitration Association and the substantive laws of the state of New York.
