TERMS AND CONDITIONS

- Park Shore Country Day Camp will be closed on Monday, July 5, 2021 . We will open on Tuesday, July 6, 2021.
- **An enrollment deposit of \$500** is required for each child, which is refundable for any reason up to Friday, March 5, 2021. There will be a 3% administrative fee added to your tuition. You can pay with check, cash or credit card. If you pay by check or cash we will waive the 3% fee.
- The balance of all tuitions is due no later than **Friday, April 16, 2021.**
- It is understood that no part of the tuition fee or deposit, except that part covered under our normal sickness refund plan (Non-Covid and Non-communicable diseases), will be refunded after Friday, March 5, 2021. **If a camper is absent due to illness or accident, as certified by a physician's letter, for 5 consecutive camp days during the camp session, a pro-rata refund will be made for every day thereafter following our current refund policy.**
- In the event camp is unable to open or is forced to begin late or close early due to circumstances beyond Park Shore's control, we will reassess our refund policy.
- It is understood that camp days may not be substituted due to illness or any other absence.
- I hereby give my consent to have my child taken to and from various field trips by means of transportation used by Park Shore Country Day Camp if transportation protocols of social distancing change during the summer.
- In the event that I cannot be reached by phone in an emergency, I hereby give my permission to my family physician, any local physician or hospital and to Park Shore Country Day Camp to administer emergency treatment to my child.
- I hereby grant permission to use any photograph, film or other image for promotional purposes, including but not limited to brochures, DVDs, our website and Facebook page and other on-line postings.
- Binding Arbitration – I agree that any dispute concerning, relating, arising out of or referring to the subject matter of this contract shall be resolved exclusively by binding arbitration in Suffolk County, New York, according to the then existing commercial rules of the American Arbitration Association and the substantive laws of the state of New York.

Park Shore Country Day Camp is licensed by the N.Y.S. Dept. of Health and is inspected twice yearly. Copies of the inspection are filed in the Health Dept. office in Riverhead.
